Requires clinics that perform abortions to report probable post-fertilization age of fetus to the WI Department of Health Services.

Requires that patients be informed of likely post-fertilization age of fetus and odds of survival if delivered.

Admitting privileges requirement of Act 37 is deemed unconstitutional. It is determined it would provide no medical benefit to women's health.

Planned Parenthood of Wisconsin loses 1/3 of its Title X contract with the federal government. It had been the sole grantee in the state for more than 40 years.

In a lame-duck session, the Wisconsin legislature passes laws which significantly limit the power of the incoming Democratic governor and attorney general.

Planned Parenthood of Wisconsin files a federal lawsuit challenging state regulations that prevent nurse practitioners from providing abortions and restrict access to medication abortion.

Planned Parenthood loses remaining portion of its Title X contract with the federal government.
